Shield:

Gules, a conventionalized castle of Ehrenbreitstein with ramp or on mount proper, debruised by a bendlet argent bearing two ribbons of the field and azure with seventeen mullets of the last. A sinister canton bendy of eight ermine and of the field.

Crest:

On a wreath of the colors, or and gules, a mount argent garnished vert, bearing a linden leaf proper charged with a fleur-de-lis argent.

Motto:

In Time of Peace Prepare for War.

Symbolism:

The field of the shield is red, the artillery color. The principal charge is the castle of Ehrenbreitstein bedruised by a bendlet carrying the American colors and seventeen stars, to signify the occupation of the castle by the 17th Field Artillery. The canton alludes to the arms of the 8th Field Artillery from which men were transferred to organize the 17th Field Artillery. The crest commemorates the two most noteworthy battle incidents. The White Mountain is for Blanc Mont. The leaf is taken from Verte Feuille Farm, on of the positions occupied by the regiment in the Soissons offensive; the linden leaf was chosen as being very common in that region. The fleur-de-lis is from the arms of Soissons.

DISTINCTIVE INSIGNIA

The distinctive insignia is the shield of the coat of arms.

The 2nd Battalion, 17th Field Artillery Regiment, 2nd Stryker Brigade Combat Team, 2nd Infantry Division in formation at Joint Base Lewis-McCord, Washington, for the brigade's deployment ceremony and casing of colors before the brigade's deployment to Afghanistan in support of Operation Enduring Freedom.

The 2nd Battalion, 17th Field Artillery Regiment deployed last April for their first tour to Afghanistan in support of Operation Enduring Freedom. The battalion has previously deployed twice to Iraq in support of Operation Iraqi Freedom. The battalion's first deployment to Iraq was from South Korea, in August 2004, and the second deployment was from Fort Carson, Colorado in October 2006.

Both the 1st and 3rd Battalions of the regiment had previously deployed to Afghanistan in support of Operation Enduring Freedom

The 1st Battalion, 17th Field Artillery Regiment deployed in August 2010 to help support the NATO efforts to train Afghan forces. The battalion's mission was to train and advise the Afghanistan National Security Forces, the battalion conducted their 21 missions at 16 different locations. The 1st Battalion returned from their first deployment to Afghanistan in July 2011. The 3rd Battalion, 17th Field Artillery Regiment, 5th Stryker Brigade Combat Team, 2nd Infantry Division deployed, in July 2009, supporting the combat missions of the brigade in and around the southern city of Kandahar, Afghanistan. The 3rd Battalion returned from their tour in Afghanistan in July 2010, just prior to the battalion's inactivation on 9 September 2010.





2/17TH ARTILLERY "THE PERSUADERS" A Unique Unit Scores Several Combat First. Story by MAJ H. Garrett Photos by SP4 T. H. Decker

Scattered throughout II Corps Tactical Zone, a rain of steel descends day and night as the 2d Battalion, 17th Artillery; "Persuaders" search out and destroy the Viet Cong.

Attached to the 41st Artillery Group, the Persuaders are unique in their organization and possess a wealth of experience at pounding the enemy ranks with their artillery might.




A member of the Persuaders directs a CH-47 "Chinook" bringing supplies to its vital Vinh Thanh Valley firebase.

Since the arrival of the 105-millimeter howitzer battalion September 5, 1965, from Fort Sill, Okla., the artillerymen earned the Presidential Unit Citation for their support of the 1st Cavalry Division (Airmobile). In Pleiku province; and received campaign streamers for participation in the Vietnam Defense (March 1964-December 1965, Vietnam Counteroffensive (December 1965- June 1966), and the Vietnam Counteroffensive, Phase II (July 1966 – May 1967).

The battalion's baptism of fire came after six days incountry when "Bravo" Battery fired the first round in support of the 1st Cav. Div. (AM). The Persuaders support of the "Sky troopers" operations was the first provided by a division-type artillery unit in Vietnam.

During "Operation Phu Ly Bridge," a five day operation north of Phu Cat in the central coastal region, the Persuaders hurried 1,300 rounds into the Viet Cong territory in support of the 22d Division, Army of the Republic of Vietnam (ARVN), thereby adding to their record another first among U.S. artillery units; reinforcing Vietnamese artillerymen.

In November 1965, near the Cambodian border, the Persuaders set still another first during the "Ia Drang Valley Campaign" by providing direct fire support to ARVN airborne brigade. In this operation six members of the battalion received the Vietnamese Cross for Gallantry.

The Persuaders tactical area of responsibility is approximately half the size of Connecticut. Working with the battalion are forward observers from the 1st Battalion, 77th Artillery; jeep mounted searchlights of "Bravo" Battery, 29th Artillery; counter-mortar radar units; and the Army's only air to ground artillery unit, the 2d Battalion (ARA), 20th Artillery.

The 105-millimeter howitzer employed by the battalion is a combat proven weapon of many capabilities. Its versatility has made the weapon one of the most used and dependable weapons in the Army's arsenal.

The battalion's firepower was increased in November 1966 with the addition of "Delta" Battery, a provisional 155-millimeter howitzer battery. The battery has been constantly on the move, as illustrated by its six moves, rotating from three landing zones, during a three-week period in the fall of 1967.

The air mobility of the Persuaders has caught the enemy unaware. The Viet Cong knows about this mobility and fears it.

This unique battalion has pumped out more than 600,000 rounds of jagged, razor-edged steel and high explosive throughout the coastal regions and central highlands of Vietnam.

The flexibility of the Persuaders allows them to conduct extensive training in addition to their operational missions. Currently the battalion is participating in the Sky troopers' replacement training program. Firing demonstrations are conducted daily for the trainees, illustrating the types of artillery fire available and how each is used. Upon completion of the training program, every man, officer and enlisted, knows how to call in effective fire support.

Also, the Persuaders operate a training school for forward observers in conjunction with the 1st Cavalry Division (Airmobile), 173d Airborne Brigade, and 41st Artillery Group.

No mission is too demanding for the Persuaders. Day or night, rain or shine, their guns are poised to render support to anyone who calls for their service.

The Wall

There are so many things that are written about the Vietnam Memorial Wall, but never anything of being "on the other side." I was inspired by the picture "Reflections" that I use as wallpaper on my PC and a recent story, "Autumn Wall."

FROM THE OTHER SIDE

At first there was no place for us to go until someone put up that Black Granite Wall. Now, everyday and night, my Brothers and Sisters wait to see the many people from places afar file in front of this wall. Many stopping briefly and many for hours and some that come on a regular basis. It was hard at first, not that it's gotten any easier, but it seems that many of the attitudes towards that war that we were involved in have changed. I can only pray that the ones on the other side have learned something and more Walls like this one needn't be built.

Several members of my unit and many that I did not recognize have called me to the Wall by touching my name that is engraved upon it. The tears aren't necessary but are hard even for me to hold back. Don't feel guilty for not being with me, my Brothers. This was my destiny as it is yours, to be on that side of the Wall.

Touch the Wall, my Brothers, so that we can share in the memories that we had. I have learned to put the bad memories aside and remember only the pleasant times that we had together. Tell our other Brothers out there to come and visit me, not to say "Goodbye," but to say "Hello" and be together again, even for a short time and to ease that pain of loss that we all share.

Today, an irresistible and loving call comes from the Wall. As I approach I can see an elderly lady and as I get closer I recognize her...it's Momma! As much as I have looked forward to this day, I have also regretted it because I didn't know what reaction I would have.

Next to her, I suddenly see my wife and immediately think how hard it must have been for her to come to this place and my mind floods with the pleasant memories of 30 years past. There's a young man in a military uniform standing with his arm around her. My God! It's...it has to be my son. Look at him trying to be the man without a tear in his eye. I yearn to tell him how proud I am, seeing him standing tall, straight and proud in his uniform.

Momma comes closer and touches the Wall and I feel the soft and gentle touch I had not felt in so many years. Dad had crossed to this side of the Wall and through our touch, I try to convey to her that Dad is doing fine and is no longer suffering or feeling pain. I see my wife's courage building as she sees Momma touch the Wall and she approaches and lays her hand on my waiting hand. All the emotions, feelings and memories of three decades past flash between our touch and I tell her that it's all right. Carry on with your life and don't worry about me. I can see as I look into her eyes that she hears and understands me and a big burden has been lifted from her.

I watch as they lay flowers and other memories of my past: my lucky charm that was taken from me and sent to her by my CO, a tattered and worn teddy bear that I can barely remember having as I grew up as a child and several medals that I had earned and were presented to my wife. One of them is the Combat Infantry Badge that I am very proud of and I notice that my son is also wearing this medal. I had earned mine in the jungles of Vietnam and he probably earned his in the deserts of Iraq.

I can tell that they are preparing to leave and I try to take a mental picture of them together, because I don't know when I will see them again. I wouldn't blame them if they were not to return and can only thank them that I was not forgotten. My wife and Momma near the Wall for one final touch and so many years of indecision, fear and sorrow are let go. As they turn to leave I feel my tears that had not flowed for so many years form as if dew drops on the other side of the Wall.

They slowly move away with only a glance over their shoulders. My son suddenly stops and slowly returns. He stands straight and proud in front of me and snaps a salute. Something makes him move to the Wall and he puts his hand upon the Wall and touches my tears that had formed on the face of the Wall and I can tell that he senses my presence there and the pride and the love that I have for him. He falls to his knees and the tears flow from his eyes and I try my best to reassure him that it's all right and the tears do not make him any less of a man.

As he moves back wiping the tears from his eyes, he silently mouths "God bless you, Dad." "God bless you, Son. We will meet someday but meanwhile, go on your way. There is no hurry. There is no hurry at all."

As I see them walk off in the distance, I yell out to them, everyone there today, as loud as I can, "THANKS FOR REMEMBERING!" And as others on this side of the Wall join in, I notice that the US flag that so proudly flies in front of us everyday, is flapping and standing proudly straight out in the wind today.
